



Pursuant to art. 13 of the Legislative Decree no. 196/2003 (code on privacy policy) we inform you about what is following:

1. **PURPOSES OF PROCESSING:** the personal information we asked for in the section above are acquired by Crisalide Network's Partners: Dolomiti Energia, SOLIDpower and Trillary in order to satisfy the forwarded request of information.
2. **METHODS OF PROCESSING:** data are processed through manual and/or IT means, according to procedures which guarantee the security and privacy. In every moment you can exercise your rights stated in the art.7 del D.Lgs. n. 196/2003, specifically, the right of asking the cancellation of the data and oppose to their processing.
3. Send an e-mail to info@retecrisalide.it, specifying in the subject:
"PRIVACY – CANCELLATION OF DATA CRISALIDE NETWORK"
COMMUNICATION OF DATA: Your data shall not be communicated to third-parties outside Crisalide Network.
4. **NATURE OF THE DATA PROVISION AND CONSEQUENCES IN CASE OF REFUSAL:** the provision of personal data is not mandatory. If you decide to refuse to provide and let process your personal data, it will consequently be impossible to contact you and therefore provide you the information you requested.
5. **SCOPE OF DISSEMINATION OF DATA:**
Within the scope of the purposes stated in this note, your personal data shall not be communicated to third-parties outside Crisalide Network.
6. **RIGHTS OF THE INTERESTED PARTY:** As an interested subject you may take advantage of the rights stated in the art. 7 of D.Lgs. 196/2003 between which, the right of receiving a confirmation of the existence or not of personal data that relate to you, the right of the update, rectification or completion of the data, the right to obtain the cancellation, transformation into anonymous form or the blockage of the data processed in breach of the

law, as well as the right to oppose the processing for the dispatch of the publication of the announcement.

The above mentioned rights may be exercised to the proprietor of the processing.

You can always contact the proprietor or the person in charge to exercise your rights as provided for in the art. 7 of the privacy code between which, the right of receiving a confirmation of the existence or not of personal data that relate to you, and to allow in the event, to make them available. Therefore, you can ask to have knowledge of the origin of the data, the logic and the purposes of the processing; to obtain the erasure, transformation into anonymous form or the blockage of the data processed in breach of the law, as well as the update, the rectification or, in case of interest, the integration of these data; to oppose, for legitimate reasons, to the processing.
